THAT: Chief and Council authorize Noah Barnaby, Sports Recreation Coordinator and Katy Scerba as Community Services Manager from Listuguj Mi'gmaq First Nation as the named contact person(s) for Aboriginal Sports and Recreation New Brunswick – NAIG, NBISG

THAT: the above authorized individuals will be able to communicate in good faith with Aboriginal Sports and Recreation New Brunswick as representatives for community athletes, invested governing bodies while accessing general information.

THAT: Listuguj will maintain a seat on the Aboriginal Sports and Recreation Board as it pertains to the Listuguj athletes participating in Aboriginal Sports and Recreation – NAIG, NBISG
