**WHEREAS:** Chief and Council of the Listuguj Mi'gmaq Government hereby issue an order, in particular under sections 28, 30, and 81 of the Indian act and Listuguj Trespass By-law #16 (October 16, 1968), requiring the persons named below to immediately leave the reserve and not return;

**WHEREAS:** on October 16, 1968, Chief and Council adopted By-law #16 regarding trespass and frequenting the reserve for unlawful purposes;

**WHEREAS:** there are non-members named below occupying and frequenting our Reserve without authorization to do so;

**WHEREAS:** the below-named individuals are trespassers and are frequenting the reserve without authorization

**WHEREAS:** the occupation, presence on Reserve and activities of the below-named non-band members are illegal, unauthorized and against the wishes of the membership and of the Chief and Council;

**THEREFORE BE IT RESOLVED:**

**THAT:** The following individuals are immediately expelled from the reserve by this order and may not return, and they are called upon to leave the reserve with their family and property immediately upon receipt of this order or notice hereof and not return:

**THAT:** the Listuguj By-Law Officer (accompanied by the Listuguj Police Department) is hereby designated to carry out this order on behalf of the Chief and Council

**THAT:** The Listuguj Mi'gmaq Government and Chief and Council reserve all other criminal, Indian Act and civil remedies against the above-named persons and all those who assist, harbor or allow them to be present on the reserve and hereby order all persons to act in accordance with this order and to govern themselves accordingly
