**WHEREAS:** The Listuguj Mi'gmaq Governments Area 12 Snow Crab licences Total Allowable Catch (TAC) for the 2025 season is approximately 1,200,000 (lbs); which represents as 35% reduction from the 2024 season.

**WHEREAS:** With the reduced quota (TAC), the NRD prioritizes six (6) LMG vessels to harvest a minimum of 175,000 lbs each.

**WHEREAS:** The NRD aims to prioritise LMG vessels and maximize the values of harvest using negotiated supply agreements.

**WHEREAS:** The Natural Resource Directorate sought Supply Agreement offers from three (3) processor companies for wharf price, profit shares price, transfer price and payment schedules.

**WHEREAS:** E Gagnon et Fils Inc. presented the best value for LMG in their 2025 supply agreement.

**THEREFORE BE IT RESOLVED:** The LMG agrees to supply E Gagnon et Fils Inc. with a total of 1,200,000 (lbs) for the exchange of the terms outlined in the 2025 supply agreement.
