WHEREAS: The 3-year noon-day lunch contract for Alaqsitew School has expired

WHEREAS: The Listuguj Mi'gmaq Government has approved 2025-2026 budgets which include costs for AGS noon-day Lunch

WHEREAS: The selection for noon-day lunch food services was tendered in 2022 and the current service provider was awarded the contract through fair and transparent process, consistent with LMG tendering policies.

WHEREAS: Through the tendering process and review of submissions it was recommended to award the contract to KB Food Service Inc.

WHEREAS: KB Food Services Inc. continues to provide noon-day lunch services, consistent with all requirements of the Alaqsitew Gitpu School.

WHEREAS: KB Food Services Inc. continues to work in collaboration with the LCHS Nutritionist to ensure quality meals for the students at the Alaqsitew Gitpu School.

WHEREAS: KB Food Services Inc., the Alaqsitew Gitpu School, and the Listuguj Education directorate have established processes for collaboration, providing feedback, and reviewing recommendations for improvements on an ongoing basis.

WHEREAS: the Listuguj Education Directorate and the Alaqsitew Gitpu School administration remain satisfied with and recommend extending the service contract with KB Food Services Inc.

BE IT THEREFORE RESOLVED:

THAT: LMG Chief and Council approve the recommendation to extend the service contract with KB Food Service Inc.

THAT: KB Food Service Inc. shall submit a proposal in advance of each school year that is subject to review and approval by LMG representatives, including at minimum, the Director of Education, the Director of Finance, the Chief Executive Officer and the Chief.

THAT: Council authorized the Director of Education, Chief Executive Officer, and Director of Finance to do all things necessary to sign and execute the contract with KB Food Service Inc. in accordance with the directives of outlined in this OIC.
