**WHEREAS:** the Listuguj Mi'gmaq Government (“LMG”) has identified the need for housing-related infrastructure to support the development of 61 new residential lots in on Atlantic Drive, including roads, storm and sanitary sewers, water distribution, and signage;

**WHEREAS:** the LMG issued a public call for tenders on June 20, 2025 for the construction work outlined in the specifications and technical plans of Project 23LST001 - Atlantic Development;

**WHEREAS:** the Project Consultant, W8banaki, conducted a thorough review of all bids received by the deadline of August 28, 2025 at 11:00 AM Atlantic Time, and confirmed the compliance and qualifications of the bidders;

**WHEREAS** the opening bid produced the following results:

**WHEREAS** the Listuguj Mi'gmaq Government has secured funding to cover at least 80% [redacted] of the total project cost, with the remaining 20% [redacted] to be covered by LMG reserve funds;
