WHEREAS: Indigenous Services Canada (ISC) has approved the Garden Center – Business Plan for a maximum contribution of ██████ under the Community Opportunity Readiness Program (CORP);

WHEREAS: the total cost of the Food Sovereignty Business Plan project is ██████ consisting of ██████ in eligible costs and ██████ in ineligible (tax) costs;

WHEREAS: ISC will contribute the lesser of \$█████ or 80% of the eligible project costs, with the remaining 20% of eligible costs (█████) to be jointly funded by the SRPNI Indigenous Initiatives Fund (IIF) at ██████ and the Listuguj Mi'gmaq Government at ██████

WHEREAS: SRPNI requires an approved Order-in-Council from the Listuguj Mi'gmaq Government before releasing its contribution of ██████ to Economic Development;

WHEREAS: the Food Sovereignty Business Plan is a key component supporting LMG's greenhouse operations, garden centre development, and long-term food sovereignty strategy;

WHEREAS: Economic Development must obtain Council approval to apply for and accept external funding on behalf of the Listuguj Mi'gmaq Government;

THEREFORE, BE IT RESOLVED THAT:

1. Chief and Council authorize the Listuguj Mi'gmaq Government to apply for and accept funding from SRPNI's Indigenous Initiatives Fund (IIF) in the amount of ██████ to support the Food Sovereignty Business Plan project.
2. Chief and Council approve the allocation of ██████ from the Listuguj Mi'gmaq Government as its required matching contribution toward the project's eligible costs.
3. Chief and Council authorize the Economic Development Department to complete and submit all necessary applications, documentation, and reporting requirements related to this funding.
4. This Order-in-Council shall serve as the formal approval required by SRPNI to release the IIF contribution for this project.
